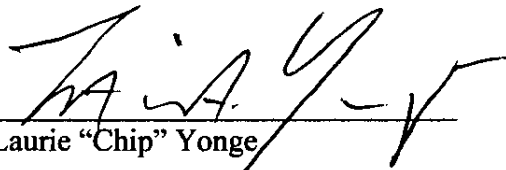

**ARTICLES OF INCORPORATION
OF
ORANGE SPRINGS SPECIALTY WATER AND BEVERAGE COMPANY, INC.**

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I: CORPORATE NAME

The name of the corporation shall be "Orange Springs Specialty Water and Beverage Company, Inc."

ARTICLE II: DURATION

The corporation shall exist perpetually unless dissolved according to Florida law.

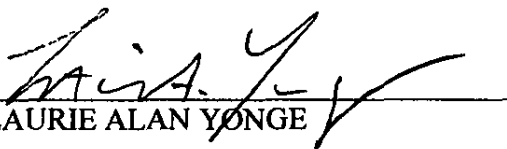

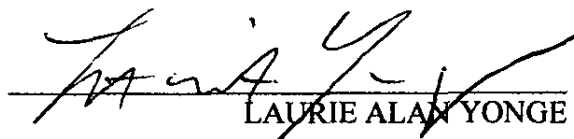
