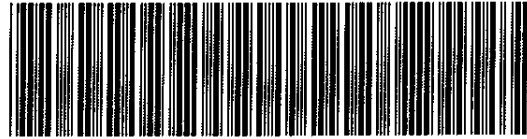

ARTICLE I - NAME

The name of the Corporation shall be "Devine Express, Inc".

ARTICLE II - PRINCIPAL OFFICE

The street address of the principal office of the Corporation shall be at 2540 NW 131st Street, Opa Locka, FL 33167 in Miami-Dade County or at such other place as may be designated, from time to time, by the Board of Directors.

ARTICLE III - PURPOSE OF CORPORATION

The Corporation is organized to conduct and shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - TERM OF EXISTENCE

The period of duration of the Corporation is perpetual.

ARTICLE V - CORPORATE CAPITALIZATION

The maximum number of shares this Corporation is authorized to issue is one hundred (100), all of which shall be Common Shares.
