ARTICLES OF INCORPORATION OF JEFF WILLIAMS LAWN SERVICE, INC.

ARTICLE I - NAME

The name of this corporation is JEFF WILLIAMS LAWN SERVICE, INC. The principal place of business of this corporation shall be 4010 NW 26th Terrace, Gainesville, Florida, 32605.
