ARTICLES OF INCORPORATION
OF
TRIAL SIMULATIONS, INC.

The undersigned, acting as incorporator of Trial Simulations, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is Trial Simulations, Inc.

ARTICLE II. ADDRESS

The address of the corporation is 101 East Kennedy Boulevard, Suite 3040, Tampa, Florida 33602.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence upon filing these articles of incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 11380 Prosperity Farms Road, #221E, Palm Beach Gardens, Palm Beach County, Florida 33410, and the name of the corporation's initial registered agent at that address is Corporate Creations Network Inc.

ARTICLE VII. INITIAL BOARD OF DIRECTORS


ARTICLE IX. BYLAWS
