**ARTICLES OF INCORPORATION
OF
INCEPTUM, INC.**

The undersigned hereby form a corporation-for-profit under the Florida General Corporation Act by adopting the following Articles of Incorporation:

1. Name and Address. The name of the corporation is Inceptum, Inc. Its initial principal office is 3640 Yacht Club Drive, #808, Aventura, Florida 33180.

2. Nature, Purpose and Powers. The corporation shall have perpetual existence, commencing on the date that these Articles are executed and acknowledged with the power to engage in any lawful business and have all powers enumerated in the Florida General Corporation Act.

3. Capital Stock. The corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

4. Initial Registered Agent and Office. The name and address of the initial registered agent of this corporation is: Lewis & White, P. L. C., 222 West Georgia Street, , Tallahassee FL 32301.

5. Initial Board of Directors. This corporation shall have one director initially. The number of directors may be increased from time to time by the Bylaws but shall never be less than one. The name and addresses of the initial director is Elizabeth Whitthorne, 3640 Yacht Club Drive, #808, Aventura, FL 33180.


6. Incorporators. The name and the address of the person subscribing to these Articles of Incorporation is Marlow White, 222 W. Georgia Street, Tallahassee FL 32301.

7. Indemnification. The corporation will indemnify any officer or director, or any former officer or director, pursuant to Section 607.014 of the Florida Statutes, as amended.

8. Meetings by Conference Telephone. Members of the Board of Directors may participate in special meetings of the board of directors by means of conference telephone or similar communications equipment as provided by law but regular meetings of the Board of Directors must be attended in fact in person by each director.

9. Informal Action of Shareholders and Directors. If all the shareholders or directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Shareholders or the Board of Directors.

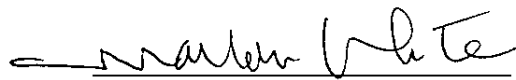

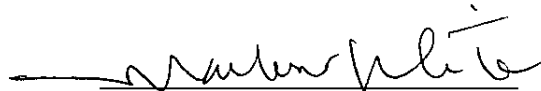
