ARTICLES OF INCORPORATION

OF

THE DANIEL LAW FIRM, INC.

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, Chapter 607, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

with any action, suit or other proceeding in which he may be involved or with which he may be threatened, or other matters referred to in or covered by said provisions both as to action in his official capacity and as to the action in another capacity while holding such office, and shall continue as a person who has ceased to be a director or officer of the corporation. Such indemnification may be entitled under any Bylaw, Agreement or Resolution adopted by the shareholders, entitled to vote thereon after notice.
