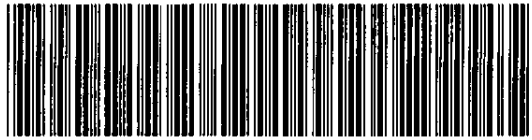

Name**


