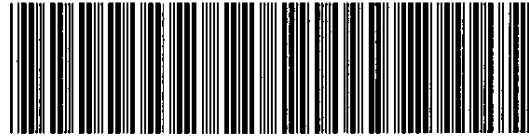

The undersigned Incorporator, in duly forming a Florida Professional Association as authorized under Chapters 607 and 621, Florida Statutes, does hereby adopt the following Articles of Incorporation as hereinafter set forth and described;

ARTICLE I - NAME OF ENTITY

The name of this corporation shall be THE LAW OFFICES OF C. W. WICKERSHAM JR., P.A. (hereinafter referenced as "the Corporation")

ARTICLE II - PURPOSE AND SCOPE OF ACTIVITIES

The objectives and purposes of the Corporation are to engage in the practice of law, and to provide legal services, guidance, and counseling to the public, and to otherwise engage in any other lawful business activity as provided by Chapters 607 and 621, Florida Statutes.

ARTICLE III - POWERS

The Corporation shall have the power to undertake any and all lawful activities, as authorized by Chapters 607 and 621, Florida Statutes, and shall have the power to undertake any other acts necessary or expedient to the prosecution of the Corporation's purposes as outlined in Article II, and any other acts necessary to carry out the legal and financial responsibilities of the Corporation.

Notwithstanding its general statement of Powers, the Corporation shall be subject to the following limitations;

- A) The Corporation shall not issue shares or distribute any other form of ownership interest to any individual or entity which is not duly licensed to practice law.

- B) No shareholder shall sell any ownership interest to any other individual or entity not duly licensed to practice law.

ARTICLE IV - OFFICERS

ARTICLE XI - BOARD OF DIRECTORS

The Corporation shall be governed by a Board of Directors, which shall initially have one (1) Director, Christopher W. Wickersham Jr., Esquire. The number of Directors may be expanded or reduced upon a majority vote of the shareholders, either at an annual meeting or at any special meeting called for that purpose.

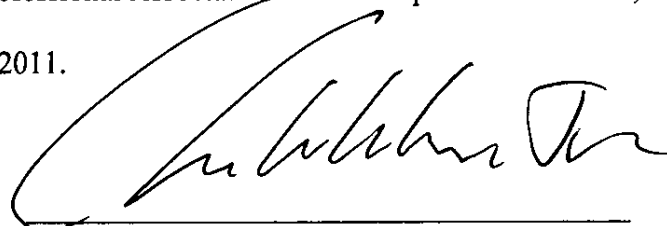
ARTICLE XII - INDEMNITY

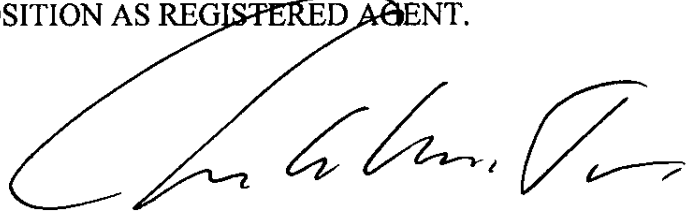
