

ARTICLES OF INCORPORATION

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

I. The name of the corporation shall be *HELPING HAND FROM HEAVEN, INC.*

The principal place of business shall be 3413 Turningwood Lane, Winter Garden, Florida 34787.

II. The duration of this corporation is perpetual unless dissolved according to law.

III. The purposes for which this corporation is organized are:

a. To provide an internet forum for customers to exchange ideas and solicit advice and donations, as well as sell advertising space to customers.

b. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporations Act.

c. To do such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.

IV. The aggregate number of shares which the corporation is authorized to issue is five hundred (500). Such shares shall be of a single class, and shall have a par value of ten dollars (\$10.00) per share.


V. The number constituting the initial Board of Directors is two (2). The method for electing Directors shall be as stated in the Bylaws of the corporation. The name and address of each person who is to serve initially are: CHARLES P. SALVO, 3413 Turningwood Lane, Winter Garden, Florida 34787; and DAVID NETZORG, 17525 Seidner Road, Winter Garden, Florida 34787.


VI. The street address of the initial registered office of the corporation is 1947 Lee Road, Winter Park, Florida 32789. The name of its original registered agent at such address is Robert T. Magill, Esquire.

VII. The names and addresses of the incorporators are the same as the initial directors, listed above.
