**ARTICLES OF INCORPORATION
OF
COMPLEX CLINICAL MANAGEMENT, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act (the "FBCA"), adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is COMPLEX CLINICAL MANAGEMENT, INC. (the "Corporation").

**ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS**


