**ARTICLES OF INCORPORATION
OF****TAMPA MEDICAL INNOVATIONS, INC.**

THE UNDERSIGNED, acting as sole incorporator of Tampa Medical Innovations, Inc. (hereinafter, the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA"), hereby adopts the following Articles of Incorporation for the Corporation, pursuant to Section 607.0201 FBCA:

ARTICLE 1**Name**

The name of the Corporation is: Tampa Medical Innovations, Inc.

ARTICLE 2**Principal Office and Mailing Address**

The location of the principal office and the mailing address shall be subject to change as may be provided in the Bylaws.

ARTICLE 3**Capital Stock**

The total number of shares of capital stock which the Corporation shall have the authority to issue shall be 10,000,000 shares, all of which shares shall be denominated "Common Stock," having a par value of \$0.01 per share. Pursuant to Section 607.0602 of the FBCA, the Board of Directors is authorized, without the approval of the shareholders of the Corporation, to (a) provide for the classification and reclassification of any unissued shares of common stock or preferred stock and determine the preferences, limitations, and relative rights thereof and (b) issue common stock or preferred stock in one or more classes or series, all within the limitations set forth in Section 607.0601 of the FBCA.


