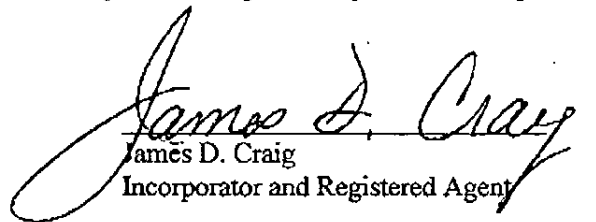
ARTICLE IX
