**ARTICLES OF INCORPORATION
OF
PORTOFINO ISLES CDD HOLDINGS, INC.**

The undersigned, acting as the incorporator of Portofino Isles CDD Holdings, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is: Portofino Isles CDD Holdings, Inc.

**ARTICLE II


