Dear Ms. Tadlock:

My name is Joseph Leon Hinzey. I am President of Leon's Marine Service, Inc., Document Number P11000095728. I understand my attorney, Michael Romm, (who is also my registered agent) spoke with you on Tuesday, February 12, 2013 at about 4:00 p.m. and discussed my failure to file the annual report for 2012 which resulted in the administrative dissolution of my company. He explained that when he originally helped me prepare and file the Articles of Incorporation back in 2011, he sent the documents for filing accompanied by a cover letter that had his business letterhead at the top showing an office in Miami and an email [mromm@jetcardplus.com](mailto:mromm@jetcardplus.com). He asked that the documents be returned to the Miami address but he did not give any instructions about how the department should contact my company for the purpose of official notices from the Division. Although he did not ask or instruct the examiner to use the email address, he did not tell her "not to use the email address" either. This left the issue "unclear". He explained to me that based on his prior experience he believed that if he provided no instructions at all, then the notices would be sent to the "principal office address" indicated on the Articles of Incorporation. The examiner placed the email address noted above into the computer records. That email address is no longer valid. Please change your records. My new email address is shown on Line #10 of the Corporation Reinstatement Form signed and included with this letter. In any event, the failure by my lawyer to clearly identify my intentions in his original cover letter led to confusion on both sides. Since the issue was "unclear" and there was confusion on both sides leading to the error, you have graciously extended a waiver of the \$600.00 reinstatement fee. Now that my lawyer has explained it to me, I fully understand that it is my responsibility to file my annual report each year between January 1 and May 1 of the current filing year. If I file after May 1, I must pay a non-waivable \$400.00 late fee in addition to the \$150.00 filing fee. Thank you very much for extending the waiver of the \$600.00 reinstatement fee. I will make sure that I take responsibility myself for filing all

future annual reports timely. Please accept the Corporation Reinstatement application which I have filled out and signed; together with the annual report fees for two years in the amount of Three Hundred Dollars (\$300.00); and this letter of explanation. Please make sure you note that I have changed the email address where I want notices to be sent. The email address is set forth on Line 10 of the Corporation Reinstatement Application Form attached and is noted in the letterhead above. Please return any correspondence by email to the same email address listed on the form.
