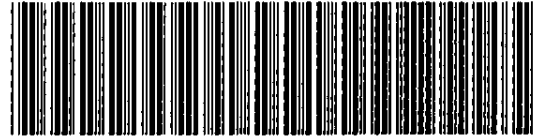

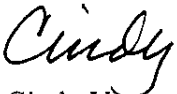

ARTICLE I--NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is REDCOM ARMS RESEARCH AND DEVELOPMENT, INC., and its principal place of business is 910 BAYSHORE DRIVE, TERRA CEIA, FLORIDA, 34250.

ARTICLE II--DURATION

This corporation shall exist perpetually.

ARTICLE III--PURPOSE

This corporation is organized for the purpose of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
