# ARTICLES OF INCORPORATION OF SEAHORSE COTTAGES ON SANIBEL, INC.

The undersigned, who, if a natural person, is eighteen years of age or older, hereby establishes a corporation pursuant to the Florida Business Corporation Act, as amended, and adopts the following Articles of Incorporation:

### Article I. Corporate Name

The name of this corporation is Seahorse Cottages on Sanibel, Inc.

### Article II. Duration

The corporation shall have an immediate effective date upon the filing of these fricles with the Florida Department of State, and shall exist perpetually.

## Article III. Purpose

The corporation is organized for the purpose of transacting any or all lawful business permitted under the laws of the State of Florida and of the United States. The corporation shall have and may exercise all the rights, powers and privileges now or hereafter conferred upon corporations organized under the laws of Florida, including the right to convey real and personal property.
