It has been brought to the attention of this office that the above referenced corporation is not located at "1 EAST OCEAN AVENUE, SUITE #120, OCEAN RIDGE, FL 33435" and service of process cannot be perfected on the corporation's registered agent at the corporation's designated registered office address of "1 EAST OCEAN AVENUE, OCEAN RIDGE, FL 33435." Please be advised that it is a third degree felony to knowingly and willingly falsify or conceal a material fact or make any false, fictitious, or fraudulent statement in any matter within the jurisdiction of the Florida Department of State.

Therefore, to correct this error on our records, you must designate a new registered agent and registered office for the corporation. Because ROCKFORD FINANCIAL CORPORATION has not filed its 2012 Corporation Annual Report form, which was due on or before May 1, 2012, the registered agent and registered office change must be submitted and reflected on the corporation's 2012 Corporation Annual Report filing. Failure to file said report with the required registered agent and registered office change on or before September 28, 2012, will result in the administrative dissolution of the corporation on the records of this office. Therefore, should decide not you decide not to file the 2012 Corporation Annual Report filing and the corporation is subsequently administratively dissolved, the corporation must still change and continuously maintain a valid registered office address on the records of this office. Please complete the enclosed form and return it to my attention along with a check made payable to the Florida Department of State for \$35.00 should the entity not file a 2012 Corporation Annual Report filing.
