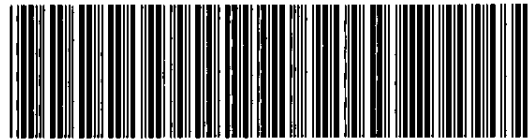

ARTICLE I. NAME

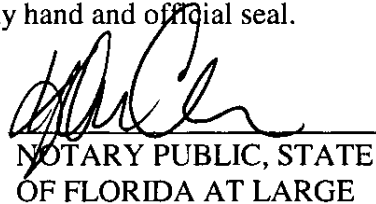
ARTICLE VI. DIRECTORS
