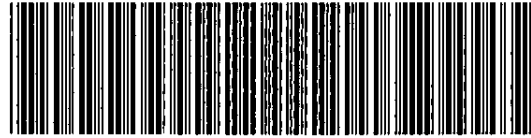

**ARTICLE IX**

PURSUANT TO CHAPTER 48.091, FLORIDA STATUTES, DAVID CAFFERY OF 330 ORCHARD STREET, CHULUOTA FL 32766 IS HEREBY NAMED AS REGISTERED AGENT OF THIS CORPORATION TO ACCEPT SERVICE OF PROCESS WITHIN THE STATE OF FLORIDA. THAT DAVID CAFFERY BY EXECUTION OF THESE ARTICLES DOES ACCEPT TO ACT IN THIS CAPACITY AND AGREE TO COMPLY WITH THE PROVISIONS OF SAID ACT RELATIVE TO KEEPING OPEN SAID OFFICE LOCATED AT THE ABOVE ADDRESS.

**ARTICLE X**


