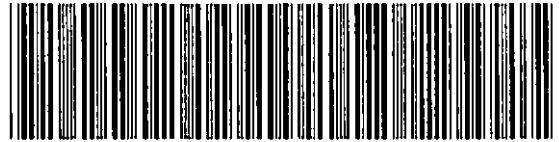

Pursuant to Section 607.1105 of the Florida Business Corporation Act (the "Act"), the undersigned hereby submit these Articles of Merger to the Florida Department of State and certify as follows:

**FIRST:** The name, jurisdiction of formation, type of entity of and document number for each party to the merger is as follows:
