**III.**

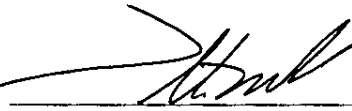
The changes made by these Articles of Amendment shall be effective upon the filing of these Articles of Amendment with the Florida Department of State.
