**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as the incorporator of Trails CDD Holdings, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**  
**NAME**

The name of the corporation is: Trails CDD Holdings, Inc.

**ARTICLE II**  
**PRINCIPAL OFFICE AND MAILING ADDRESS OF THE CORPORATION**


