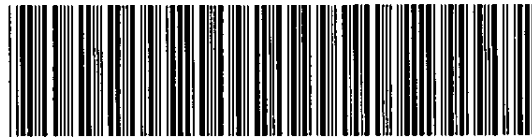

The undersigned, acting in his capacity as President of Total Roof Services Corp. (the "Corporation"), a Florida corporation, on behalf of the Corporation, has executed these Amended and Restated Articles of Incorporation, approved by the Directors of the Corporation in an action by written consent, pursuant to Florida Statutes Section 607.0821, effective May 22, 2015, and as approved by the shareholders of the Corporation, in an action by written consent, pursuant to Florida Statutes Section 607.0704, effective May 22, 2015. The number of votes cast by the shareholders by written consent was sufficient for approval.

These Amended and Restated Articles amend and restate in their entirety the Corporation's Articles of Incorporation, as filed with the Florida Department of State on November 14, 2011.

ARTICLE I-NAME/ADDRESS

The name of the Corporation is Total Roof Services Corp. The street address of the principal office of the Corporation is 1820 N. Rio Grande Avenue, Orlando, Florida 32804.

ARTICLE II-DURATION

The Corporation shall exist perpetually.

ARTICLE III-PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV-CAPITAL STOCK

The maximum number of shares of capital stock that the Corporation is authorized to issue and have outstanding at any one time is One Thousand (1,000) shares of common stock having no par value.
