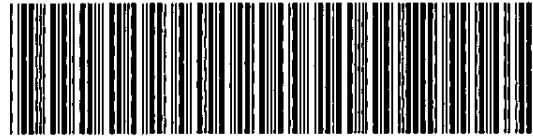

**ARTICLE II - REGISTERED OFFICE AND AGENT**


## **ARTICLE VI - AMENDMENTS**

## **ARTICLE VII - INCORPORATOR**


