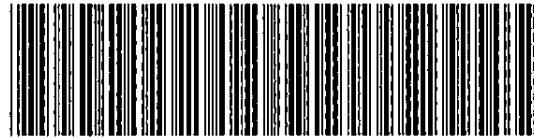

**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is Air Doctor Air Conditioning & Heating of Orlando, Inc., and the principal address and principal place of business is 1975 Levine Lane, Clearwater, Florida 33760.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

#### **ARTICLE VI - AMENDMENTS**




