ARTICLES OF INCORPORATION  
OF  
TT OF AIRPORT, INC.  
(a Florida corporation)

Pursuant to Florida Statutes Section 607.0201, the undersigned hereby submits the following Articles of Incorporation of TT OF AIRPORT, INC., a corporation being organized under the laws of the State of Florida.

ARTICLE I.  
Name

The name of the Corporation is "TT OF AIRPORT, INC." (hereinafter called the "Corporation").

ARTICLE II.  
Purpose

The Corporation is formed to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act, Chapter 607, Florida Statutes (the "FBCA"), including any amendments thereto.

ARTICLE III.  
Initial Principal Office

The street address and mailing address of the initial principal office of the Corporation is 505 South Flagler Drive, Suite 700, West Palm Beach, FL 33401.

ARTICLE IV.  
Capital Stock

The capital stock authorized and the characteristics of such stock shall be as follows:
