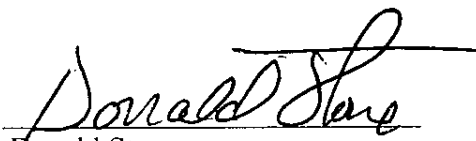
#### ARTICLE I X - PREEMPTIVE RIGHTS

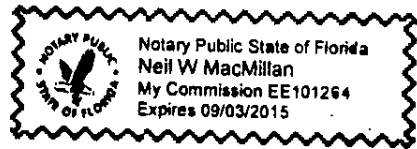
