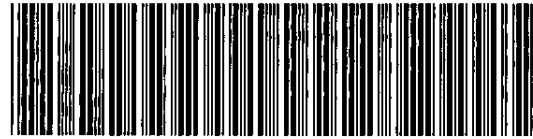



OF






