**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida Professional Service Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE ONE

7.01 Two directors shall constitute the initial Board of Directors of the corporation, but the Bylaws may provide for such increase or decrease in number thereof as is authorized by law.

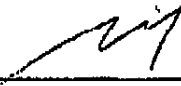
