**ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name and street address of the incorporator is George Menzies, Jr., 701 Brickell Avenue, Suite 3000, Miami, Florida 33131.

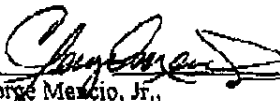
ARTICLE IX. BYLAWS
