Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of **Apollo Ship Changers No. 22, Inc.**, a Florida corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is **Apollo Ship Changers No. 22, Inc.**

SECOND: The Articles of Incorporation of the Corporation are hereby amended by deleting the entire Article I as it now exists and inserting in lieu thereof a new Article I, reading as follows:

"ARTICLE I. NAME

The name of the Corporation is **Anajor Trading Inc.**"

THIRD: The effective date shall be the date these Articles of Amendment to the Articles of Incorporation are approved by the Florida Department of State.

FOURTH: The foregoing amendment was adopted by written consent of the board of directors without shareholders action, and shareholders action was not required.
