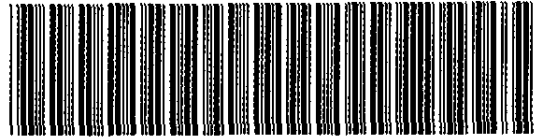



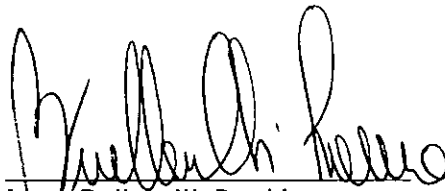
ARTICLE I
