Mohsen T. Mohammadpour is *deleted* as Registered Agent of the Corporation.

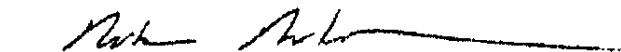
Felix I. Ogbechie shall be the new Registered Agent of the corporation at 12486 SW 8th Street, Miami, Florida 33184.
