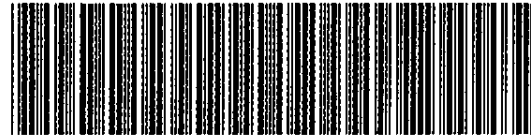



ARTICLE V. PREEMPTIVE RIGHTS


Every shareholder, upon the sale for cash of any new






