## ARTICLES OF INCORPORATION OF

SARASOTA WINDOW AND DOOR SCREEN, INGALLAHASSEE, FLORIDA

#### **ARTICLE 1**

Name. The name of this corporation is SARASOTA WINDOW AND DOOR SCREEN, INC.

#### **ARTICLE II**

<u>Duration</u>. The corporation shall be perpetual.

#### **ARTICLE III**

Purpose. This corporation is organized for the purpose of transacting any or all lawful business.
