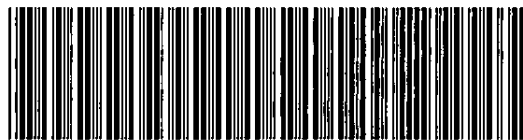


I personally designed this trademark years ago, had a graphic artist produce it, and registered it with you.
