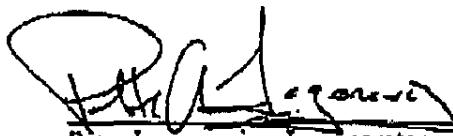
ARTICLE VII - INDEMNIFICATION

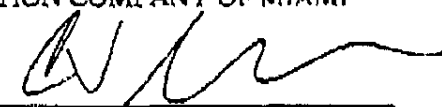
