ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is Kim's Salon, Inc., at 3425 Bayside Lakes Blvd., #102, Palm Bay, FL 32909 (Principal Office of Registered Agent).

ARTICLE II - DURATION

ARTICLE VIII - INITIAL BOARD OF DIRECTORS


