ARTICLES OF AMENDMENT

1. The name of this Corporation is Children's Express Care Clinic, Inc.
2. The Articles of Incorporation of Children's Express Care Clinic, Inc. have been amended by deleting Article I in its entirety and by substituting in lieu thereof the following Article I:

"ARTICLE I - Name


The name of this Corporation shall be:
