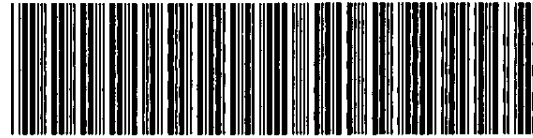

**ARTICLES OF AMENDMENT
to the
ARTICLES OF INCORPORATION
of
ISTAR FLEET SAFETY SYSTEMS, INC.**

Pursuant to, and with the effect provided in, Section 607.1006 of the Florida Statutes (the "Statutes"), the undersigned corporation adopts the following amendment to its Articles of Incorporation:

FIRST: The name of the corporation is iStar Fleet Safety Systems, Inc. (the "Corporation").

SECOND: The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on December 12, 2011.

THIRD: The Articles of Incorporation of the Corporation are hereby amended by deleting Article I in its entirety and substituting in lieu thereof the following:

"ARTICLE I

The name of the corporation is VisInt, Inc. (the "Corporation")."

FOURTH: This amendment was adopted and approved by the shareholders holding a majority of the outstanding shares of common stock, par value \$.01 per share, of the Corporation. The number of votes cast for the amendment by the shareholders was sufficient for approval by the Statutes.
