**ARTICLES OF INCORPORATION
OF
SIMPLY BETTER HEALTH, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is SIMPLY BETTER HEALTH, INC. (hereinafter called the "Corporation").


**CERTIFICATE OF ACCEPTANCE BY
