**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF  
RINEVE HOLDINGS CORP.

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of RINEVE HOLDINGS CORP., a Florida for profit corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is Rineve Holdings Corp.

SECOND: "Article I" of the Articles of Incorporation is amended in its entirety to read as follows:

**"ARTICLE I**
