ARTICLES OF INCORPORATION

FOR

BOWLEDER RESTAURANT, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is Bowleder Restaurant, Inc.



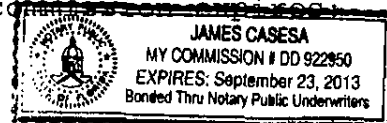


