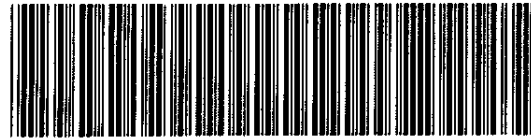


This is to inform that Tomorrow's veterinarians, L.L.C., has the same entities as Tomorrow's Veterinarians, INC.


