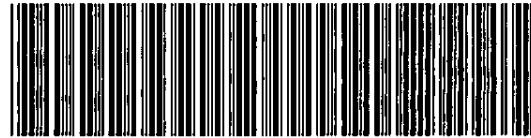

ARTICLE I. NAME

EFFECTIVE DATE 1/1/12

The name of this corporation is

ARTICLE II. DURATION

This corporation shall commence January 1, 2012, and




