The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I – Name

The net assets of the corporation remaining after winding up must be distributed to the shareholders after payment of all debts of all debt of the corporation.

These articles of Incorporation may be amended in the manner provided by law. Every amendment and all changes related to tangible and intangible assets of this Corporation shall be approved by the Board of Directors, Proposed by them to the stockholders and approved at a stockholders meeting by a majority (minimum of 51%) of the stock entitled to vote thereon, unless all the Directors and all the stockholders sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation be made.

ARTICLE XII – *Effective Date*


These Articles of Incorporation shall be effective *January 1st, 2012*, upon approval of the Secretary of State, State of Florida.
