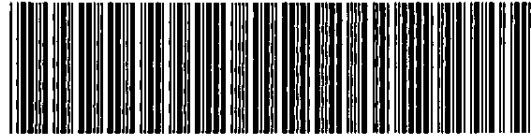

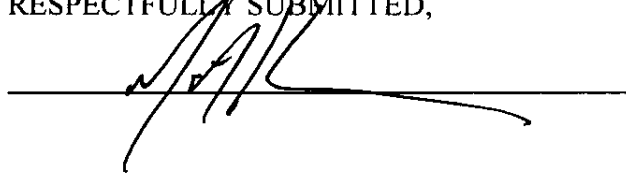

ARTICLE I NAME

The name of the corporation shall be **DYNASTY INTERNATIONAL PRODUCTIONS, INC.**

ARTICLE II PURPOSE

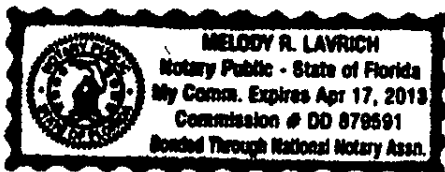
