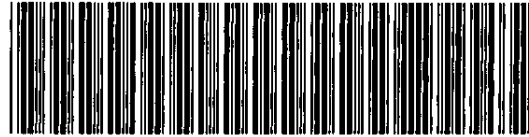

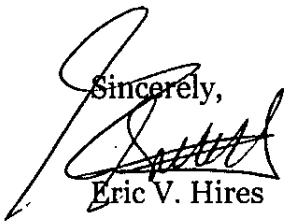

The under signed, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

### ARTICLE I: NAME

The name of this corporation shall be **Forest City Studios, Inc.**

### ARTICLE II: DURATION OF BUSINESS

The term of existence shall begin December 20, 2011, and shall be perpetual.

### ARTICLE III: NATURE OF BUSINESS

The general nature of the business to be transacted by the corporation shall be and is to engage in the production, sales and distribution of written material, music and other music related material. in all forms (i.e., cd, video, digital, mp3, etc).

### ARTICLE IV: CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be one thousand (1,000) shares of common stock. Such shares shall be single class, and shall have a par value of One Dollar (\$1.00) per share.

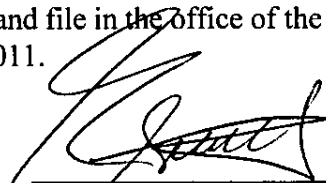
## **ARTICLE X: SEAL**

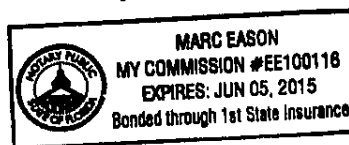

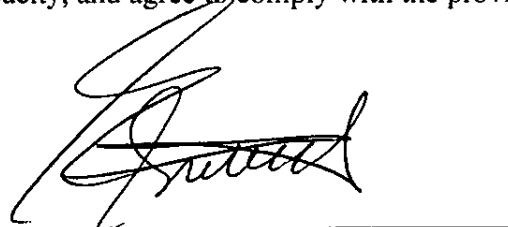
