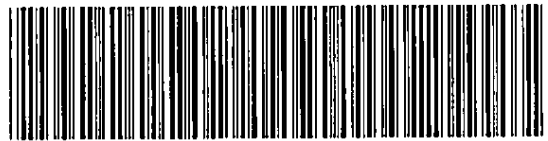

Pursuant to Section 607.1006 of the Florida Statutes, The Focus Group, Inc., a Florida corporation, does hereby adopt the following amendment to its Articles of Incorporation:

CHANGE OF CORPORATION'S AUTHORIZED COMMON STOCK

1. Pursuant to the separate "Action By Unanimous Written Consent of the Directors" approved on January 2, 2023 by the unanimous vote of the Directors and the "Action By Unanimous Written Consent of the Shareholders" approved on January 3, 2023 by the unanimous vote of the Shareholders, the authorized shares of common stock of the Corporation and the outstanding shares of common stock of the Corporation shall be changed as specifically provided in the above-referenced Actions By Unanimous Written Consent; and Article IV of the Articles of Incorporation of The Focus Group, Inc. is hereby replaced and amended to read as follows:

ARTICLE IV
SHARES OF STOCK

The Corporation's shares of capital stock are hereby recapitalized as follows:

Authorized Shares:

The maximum number of shares of common stock that the Corporation is authorized to issue at any given time is increased to Five Hundred Thousand (500,000) shares of common stock having a par value of \$1.00 per share.

Outstanding Shares:

All of the outstanding shares of the Corporation's stock, as of December 31, 2022, consisting of One Hundred (100) shares of common stock are hereby reissued newly authorized shares of common stock using the following formula: Each share of outstanding stock (or fractional share thereof), as of December 31, 2022, shall be multiplied by a factor of One Thousand (1,000) to determine the total number of outstanding shares of newly authorized common stock of the Corporation owned by each shareholder, in full substitution thereof.

EFFECTIVE DATE

2. The change of the Corporation's authorized common stock, as provided herein, shall be effective on the filing of these Articles of Amendment with the Florida Department of State.
