#### ARTICLES OF INCORPORATION

**OF** 

#### SIMEON D. BRIER, P.A.

The undersigned subscriber to these Articles of Incorporation, being an attorney duly licensed to render legal services as such under the laws of the State of Florida, hereby presents these Articles for the formation of a corporation under the Professional Service Corporation Act, and other laws of the State of Florida.

- 1. Name. The name of the Corporation is Simeon D. Brier, P.A. (the "Corporation".)
- 2. <u>Nature of Business</u>. The general nature of the business to be transacted by the Corporation is:
- (a) To engage in every phase and aspect of the business of rendering the same legal services to the public that an attorney duly licensed under the laws of the State of Florida is authorized to render, provided such legal services shall be rendered only through officers, employees, and agents who are duly licensed or otherwise legally authorized under the laws of the State of Florida to render legal services.
- (b) To the extent permitted under the Professional Service Corporation Act and under the laws of other states, to engage in every phase and aspect of the business of rendering the same legal services to the public that an attorney duly licensed under the laws of such other states is authorized to render, provided such legal services shall be rendered only through officers, employees, and agents who are duly licensed or otherwise legally authorized under the laws of such states to render legal services.
- (c) To invest the funds of the Corporation in real estate, mortgages, stocks, bonds, or any other type of investments, and to own real and personal property necessary for the rendering of professional legal services.
- (d) To do everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the Corporation, and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful activity necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of the Corporation.

The foregoing paragraphs shall be construed as enumerating both the objects and the purposes of the Corporation; and it is hereby expressly provided that the foregoing enumeration

of specific purposes shall not be held to limit or restrict in any manner the purposes of the Corporation otherwise permitted by law.

- 3. <u>Capital Stock.</u> The Corporation is authorized to issue 1,000 shares of common stock having a par value of \$.001 per share. None of the shares of the Corporation may be issued to anyone other than an individual duly licensed to render legal services in the State of Florida.
  - 4. <u>Duration</u>. The Corporation shall have perpetual existence.

- 9. <u>Voting Trusts</u>. No shareholder of the Corporation shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his or her shares.

The indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, agreement, vote of shareholders or disinterested directors or otherwise, both as to action in his or her official capacity and as to action in another capacity while holding such office. Such indemnification shall continue as to a person who has ceased to be a director, officer, employee or agent, and shall inure to the benefit of the heirs and personal representatives of such a person. An adjudication of liability shall not affect the right to indemnification for those indemnified.

15. <u>Effective Date</u>. The Effective Date of these Articles of Incorporation shall be January 1, 2012.
